# Training Report April 2021



According to the Commission on Accreditation for Law Enforcement Agencies, police are expected to be more proactive and strive to prevent crime, while building relationships within the community. This is a delicate balance that is difficult to achieve and maintain. To that end, police training involves more than knowing how to pat down someone that's detained, or how to shoot a gun, it's also about listening to people, watching for trends, and preparing for outcomes. SARPD Officers maintain a high level of moral and ethical values, and will continue to achieve this through training and education.

#### **Training**

Throughout the month of April, Officer Cohowicz, Officer Petruzzi and Cpl. Dobson set up and conducted scenario based "Use of Force" training through the firearm's simulator. The majority of officers in the department went through the training in March. Officers that missed the March trainings completed this training in April.

**April 12<sup>th</sup>, 2021** through the 16<sup>th</sup>, Officer Cohowicz attended the Pennsylvania State Police Instructor Development course.

April 12th, 2021, K-9 Officer Sampere attended his bi-weekly training in Lancaster, PA.

#### STROUD AREA REGIONAL POLICE DEPARTMENT: APRIL 2021 MONTHLY REPORT

**April 13, 2021**, members of the SARPD Special Response Team attended bi-weekly training at the Brushy Mountain Range. Members worked to improve on the team's shooting skills and weapon handling through the use of established drills and training methods. Members that were in attendance, included Instructor Mike Petruzzi, Cpl. Petrosino, Detective Knowles, Officer Taylor, Officer Labar, and Officer Eilber.

**April 20<sup>th</sup>, 2021**, members of the SARPD Special Response Team attended bi-weekly training. This training focused on team movements. Members that attended this training included Sgt. Brown, Cpl. Miller, Officer Petruzzi, Officer Cohowicz, Cpl. Petrosino, Officer Labar, Officer Eilber, and Detective Knowles.

For the Month of April 2021, the Detective Unit was involved in several activities within the member municipalities of Stroud Township and the Boroughs of Stroudsburg and East Stroudsburg.

Details of some of these activities follow:

## MAJOR CRIMES ASSAULTS

For the month of April, 2021 there were 4 aggravated assaults reported to the Stroud Area Regional Police Department. Of these assaults:

- 1 occurred in Stroudsburg Borough
- 1 occurred in Stroud Township
- 2 occurred in East Stroudsburg Borough

On April 10, 2021, Patrol received a call from crisis advising a male was at the Lehigh Valley Pocono Hospital ER with a stab wound. Patrol was advised the victim was going to be transported to Lehigh Valley Hospital Cedar Crest for additional treatment. Patrol responded to the hospital to take an initial statement from the victim. It was learned the victim lived with a male roommate that he subsequently had been in a dispute with. During the argument, the male had a knife in his hand and became very angry and while talking with his hands he cut the victim in his face. The victim stated he was not sure if it was on purpose. The Detective Unit was notified and the on call Detective took over the investigation.

On April 22, 2021, Patrol Units were dispatched for a report of a physical domestic assault with injury in the Borough of Stroudsburg. Upon the arrival of multiple Patrol Units, a female was found with multiple injuries and was bleeding; an ambulance transported her to the hospital. Shortly after, a male was located and it was determined he was the actor in the domestic assault and detained by Patrol Units. The on call Detective was contacted and responded to the scene. Search warrants were obtained for location of the incident and the body of the male actor. Another Detective responded to the hospital to conduct a full interview with the female victim. Pennsylvania State Police Forensic Unit was contacted and subsequently assisted by processing the scene. The Monroe County District Attorney's Office and the County Detective Office was notified as per County protocol.

#### **SEX & FAMILY CRIMES**

For the month of April 2021, 11 new sex crimes and possible child abuse cases were reported to the Stroud Area Regional Police Department, 9 cases were referred to the Detective Unit for further investigation.



In relation to the above assigned cases 3 were sex crimes, 6 were suspected child abuse cases.

The 9 cases referred to the Detective Unit remain under investigation.

In the majority of these open cases, the alleged perpetrators are known or have been identified through investigation. The investigations are still ongoing to determine if an actual crime was committed and if so to establish enough probable cause to make an arrest. Due to the nature of these crimes and/or the age of the victims, no further information can be released at this time.

#### **ROBBERY**


For the month of April, 2021 the Stroud Area Regional Police Department did not received any robbery reports.



#### **BURGLARY**

For the month of April 2021, the Stroud Area Regional Police Department responded to 1 burglary calls that were reported within the member municipalities. Of these Burglary reports;

1 occurred in Stroud Township



On April 20, 2021, Patrol Units were dispatched to a residence in Stroud Township for a report of a possible burglary in progress. The caller reported an unknown vehicle at a neighbor's home with a male driver loading items into his trunk. Upon the arrival of the dispatched Officer, he encountered a male on the property and with the assistance of 2 sheriff deputies that respond the male was taken into custody. During the initial investigation, the homeowner arrived on scene and confirmed

he did not know the male and did not give him permission to be on his property or remove any of his property that was in the vehicle. The Detective Unit was not requested to process the location.

#### **UNATTENDED DEATHS**

For the month of April, 2021 there were 2 death cases, and through investigation 1 case has been closed due to natural/medical condition. Detectives did respond to the one equivocal death investigation. The on call Detective was notified and responded to the scene. Multiple Detectives assisted with processing the scene, conduct multiple interviews, and making necessary contacts as per protocols. The death remains under investigation.

During the month of April there were 3 medical emergency overdose cases not resulting in death.

The DDRD, (drug delivery resulting in death) are joint investigations with the Monroe County District Attorney's Office and County Detectives as required by the Monroe County death protocols. The investigation includes scene processing, multiple search warrants, cell phone analysis, multiple interviews and continued efforts with the County Detective to uncover additional intelligence to locate the individual that sold the narcotics to the decedent. The case is considered a homicide investigation and continues to be investigated as such.

The Detective Unit was contacted on all of the above death cases and continues to work with the Monroe County District Attorney's Office and Monroe County Coroner's Office as required with equivocal deaths.

The 2020/2021 is coming to an end on June 9<sup>th</sup>, 2021. A large majority of students returned to school on a 4 day in person school day with all students learning from home on Wednesdays. Next school year the district is planning on having students return five days a week for in-person learning with the only alternative being cyber school.

This month at the Stroudsburg School District, Officer Cohowicz investigated and took reports on the following:



- Investigated a report of an ATV on school property riding around the bus loop. There were
  no students in school on this day for Easter holiday. Located same riding slowly. Moved him
  along to his residence.
- Called to Principal Sodl's office for a student who was being questioned on plagiarism.
   Conversation became heated and Principal Sodl ordered student to remove himself from the office but he was refusing and attempting to speak with the principal. He eventually had to be escorted out of the office. I was able to calm the student down in my office.
- Report from SASD bus driver reporting a suspicious male telling him not to park where he
  was pulled off on Chipperfield Drive.
- Student searched by Assistant Principal and (4) vape pens were found and furnished to me.
   Devices were all negative for THC. Student cited for Use of Tobacco Products in Schools Prohibited.
- Student in possession of a vape pen recovered by Assistant Principal and furnished to me.
   Same tested positive for the presence of THC oils. After discussion with DA's office and speaking with student and family, student was filed a citation for Use of Tobacco Products in Schools Prohibited.
- Counseled a student who was having an issue with one of her ex's. Provided some guidance.
- Called to second floor G hallway bathroom by school nurse for a student passed out in bathroom stall. Called EMS. Student was transported to St. Luke's hospital by Suburban EMS.

- SASD transportation reported a bus red light violation occurring at Dreher Avenue and West Main Street. Investigation revealed a rental car.
- Assist HS administration team in tracking different students in (3) separate incidents cutting class.
- Filed juvenile referral against student from prior incident involving terroristic threats

#### Middle School

Investigated a male who was at the school picking up a book for a student. School security
believed the male was carrying concealed. Male did not cause an issue and left without
issue. Later reported to me and male was identified. Insufficient evidence was presented as
to whether male actually possessed a firearm. School video shed little clarity. Incident
closed at this time.

#### Stroudsburg Jr. High School

- Investigated a student who posted in a Zoom chat about hearing that someone was going to shoot up the 8<sup>th</sup> and 9<sup>th</sup> grade. Investigation revealed student was autistic and was making an April Fool's joke.
- Interview of student with parent from a prior sexting investigation. After speaking with DA's
  office, victim, and offender parent, student will be completing an essay. Topic is to research,
  identify, and explain the charges to Harassment by Communication and Transmission of
  sexually explicit images by minor.
- Met with Assistant Principal and a student who made prior comments at the afternoon bus ramp about saying to the AP as he walked by "welcome to the hit list". Student was in emotional support. I had a long conversation with student about how his actions and words

can affect him not only today but in the future. During the final week in April I stopped up to the school to follow-up with the student who has made a positive change.

Investigated a juvenile female student who was jumped by two juvenile female students in a hallway. Citation pending.
